### Dear Parent/Carers,

I write to thank you for all your support since we have returned after Easter and to wish you all a happy half term break. I would also like to congratulate our Year 11 students on completing a particularly challenging few weeks and in working towards achieving their desired GCSE grades. It has been a monumental effort both by students and staff and I would like to congratulate and thank all involved. This Friday is the last day of timetabled lessons for our Year 11 students. ## **E-Scooters**

The police and local authority are asking for school and parental support in regard to discouraging the use of E-Scooters by children and young people. Not only is there real concern around how some of these may be used in terms of road safety, many people may be unaware that the use of E-Scooters is actually illegal when driven in public places and on roads in London and the UK.

E-Scooters are classed as motor vehicles so riders must comply with various pieces of Road Traffic Legislation, including:

- driving with a licence
- driving/riding with insurance
- driving/riding other than on a road
- need to be taxed

If stopped using an E-Scooter illegally, the rider, even if a young person, could received fixed penalties, penalty points, or even face prosecution. Vehicles are also likely to be seized and potentially destroyed.
